# AGENCY PRESENTATION- Oliver Harwood, Paralegal, Disability Advocacy Project, Public Benefits, New York Legal Assistance Group

- Oliver is a paralegal in the Disability Advocacy Project, where he provides advice, advocacy, and full representation to those who have been wrongly denied Social Security benefits.
- He encouraged attendees to contact him if need help for a client particularly regarding termination or overpayment of Social Security Disability (SSD) and Supplemental Security Income (SSI): <a href="mailto:OHarwood@nylag.org">OHarwood@nylag.org</a> and 212-613-5071
- Oliver presented some case histories of his clients and there was considerable discussion and Q&A with the meeting attendees, which included two Social Security Administration representatives.
- o Key points
  - A Social Security Administration office typically sees 150 clients a day.
  - Each situation regarding Social Security benefits can vary and how it is handled by Social Security Administration staff can vary by the office and the staff member.
  - In NY, if there is a 10 year difference between the perpetrator and the 65+ year old victim, then the level of crime may be elevated
